- 3. If a player withdraws from MAHA membership, or if the membership is terminated for any reason, all fees paid are forfeited and payment of any unpaid fees is accelerated and becomes immediately and fully due.**

**The Registration/Tryout fee is Non-Refundable in any situation.**

If a player withdraws from MAHA membership or if membership is terminated for any reason, all fees paid are forfeited and payment of any unpaid fees is accelerated and becomes immediately and fully due and payable.

I (we) agree that I (we) are financially responsible for the purchase and maintenance of two (2) sets of MAHA game jerseys and socks, (1-home, 1-away) and for the return and/or replacement and repair of any equipment that may be assigned, which is lost, stolen or damaged beyond reasonable wear and tear in the field of play.
