### COMMITMENT FORM

1. I agree to pay a \$50.00 tryout fee and a \$100.00 commitment fee in consideration for participation in the MAHA 2008-2009 season at the time of tryouts.
2. Players will be notified of their placement via telephone call after their participation in both days of tryouts. Players will have until May 23, 2008 to decline their placement and have their commitment fee returned. Players wishing to decline placement must email Doug DeNardo at [ddenardo@rothmangordon.com](mailto:ddenardo@rothmangordon.com).
3. If the player is not placed on a team, the \$100.00 commitment fee will be returned.
4. After the final date to decline placement, *the commitment fee is non-refundable*.
5. After placement on a team, I will register my player(s) with USA Hockey by online registration at [www.usahockeyregistration.com](http://www.usahockeyregistration.com). (Webpage attached) The USA Hockey fee is \$30.00 if age 7 or older. The Mid Am fee is \$5.00 per player. I will make these payments at this time online by June 30, 2008 and will notify Doug DeNardo or the MAHA Registrar of this registration by email to [ddenardo@rothmangordon.com](mailto:ddenardo@rothmangordon.com).
6. I agree to pay the entire assessment for the player's assigned placement level for the 2008-2009 season and understand that all fees paid are NON-REFUNDABLE.
7. If a player voluntarily withdraws from the MAHA for any reason, fees paid on behalf of the player are forfeited and the commitment to make the remaining assessment payments remains in effect.
8. A \$100 sibling discount will be given for each additional child when more than one member of the same family plays for MAHA.
9. If a team has two goalies and a goalie elects to "skate out" when he/she is not in the net, they must pay the full player fee.
10. Fees for fundraiser credits are non-transferable between players.
11. I agree that I am financially responsible for the purchase of two MAHA game jerseys and socks, (one home and one away) and for return and or replacement and repair of any equipment that may be assigned to my child, which is lost, stolen or damaged beyond reasonable use in the field of play.

12. Offer of Membership: By signing this document you agree and understand:

- a. That membership to the MAHA is conditional upon an offer of membership extended by the organization. Said offer is discretionary and solely the responsibility of the MAHA Board of Directors, regardless of the skill level of your child and said Membership can be denied for any reason by said board.
- b. That the player is selected during the normal evaluation process and is offered a position on a team.
- c. That you accept and adopt all MAHA, PIHL, and USA Hockey rules and regulations and agree to pay any and all monies due, as determined by the Board.
- d. That both the parents/guardians and player will abide by the USA Hockey Zero Tolerance Policy and USA Hockey's Code of Conduct while participating in any and all MAHA activities.
- e. That you are held personally liable for any property damage caused by the player.
- f. That you consent to and authorize the player to participate in all phases of the program. You hereby represent that the player is physically and mentally fit to engage in this program and that the player has no pre-existing or known physical or mental incapacity that would increase the normal risk of injury to the player or other program participants. It is understood that no physical examination of the player will be made by MAHA prior to the player's participation in the program to verify the truth of your representations.
- g. In the event the player becomes ill or injured while participating in the program or related activity, including travel to and from such activities, and no parent or guardian being present, MAHA officers, directors or its agents are hereby authorized to obtain all reasonable and necessary medical care for the player from an appropriate medical care provider.

13. Limitation of Participation: While the philosophy of the MAHA is to enable as many players to participate in its program as possible, MAHA reserves the right to limit participation after registration based on the number of players and PIHL teams entered into competition and the availability of qualified coaches and instructors. I understand that signing this agreement does not guarantee my child a position in the MAHA or on any MAHA team. The tryout fee will not be refunded should your child be selected for a team and decide to voluntarily withdraw after selection has been made.

14. In consideration of acceptance of my child to play for and with the MAHA (PIHL), I (we) the undersigned, agree to assume all risks and hazards incidental to player's participation including those involved in traveling to and from all such activities and on behalf of the player, do hereby release, absolve, indemnify, and hold

harmless the Pennsylvania Interscholastic Hockey League (PIHL), Moon Area Hockey Association (MAHA), its Directors, Officers, Coaches, Officials and their agents for any claim for injury, loss, damage, death or expense sustained by the person or property of the player except to the extent covered by USA Hockey Insurance and/or the undersigned arising during any game, exhibition, practice, travel, or other activity. I further consent to the player participating in the said activity with full knowledge of the inherent risk related thereto.
